GOALS:

1. To examine the meaning, content, methodologies and practical implications of Christian Social Teaching.

2. To focus our exploration principally on Catholic Social Teaching while also considering other faith based and secular approaches.

3. To give particular attention to the social, historical and methodological factors related to the development of these teachings.

4. To become aware of some of the social problems of our time and our milieu, to reflect on them in the light of the Church's teaching, to discuss these issues and to discover possible avenues of hope-filled, just action.

A. Knowledge

1. To know the history of the Catholic Church's social justice tradition.

2. To study and have a familiarity with the principal magisterial documents of the Church's social teachings on the papal and universal level, on the regional and national level, and on the provincial and diocesan level.

3. To have a critical knowledge of the significant methodological changes and the underlying constants in the development of the social teaching of the Catholic church.

4. To have a knowledge of the theories and methods needed to develop strategies for relating Christian Social Teaching to the social mission of the Church at the parish and local level.

5. To be able to understand and articulate specific social issues and problems that influence society and the Church today on the local, national and international level in order to be able to formulate possible Christian Catholic responses.

B. Skills

1. To be able to understand and interpret the historical development of the Church's Christian Social teaching in the broader ecclesial and secular historical context.

2. To be able read and analyze the Church's Social documents.

3. To be able to understand and apply appropriately Christian and theological social principles in concrete social analysis.

4. To develop the practical skill of working with others in applying different methods of social analysis: for example "See, Judge, Act".

5. To develop the oral and writing skills needed to articulate clearly and faithfully the Christian Social Teaching and its practical application to specific issues and problems.

C. Values and Attitudes

1. To appreciate the importance of the Church's Social Teaching as an integral and constitutive part of the total doctrine of the Catholic Church.

2. To develop a sense of solidarity with, and love for, the poor by making a preferential option for the poor and oppressed rooted in our faith in Jesus Christ.

3. To appreciate the need for justice and peace in our global and local world, and the urgency for those in the Church to work for these values with all people of good will.

4. To value the connection between spirituality and social justice in forming agents for social change with the heart and mind of Jesus Christ.

Methodology:

The course includes reading, lectures, discussion, student presentations and papers.

Assignments:

1. Read and study the required texts.

2. Read and be conversant with the supplementary material indicated in the class lectures, for example articles, videos, interviews, etc.

- 4. Complete the required papers, seminars and tests.

Part one will clearly present the social issue according to the method of social analysis presented in the course. {SEE}

Part two will make judgements on the issue drawing on the teachings, principles and documents studied this semester. {JUDGE}

Part three will consider possible steps to be taken to work toward a solution of the problem studied. {ACT}

2. Policies regarding Submission of Assignments and Tests
